

Announcement of the date of elections to the school board

Based on §167 and §168 of Act No. 561/2014 Coll., on pre-school, elementary, secondary, higher vocational and other education (Education Act), I am communicating details about the elections to the school board of 1st International School of Ostrava - mezinárodní gymnázium, s.r.o.

In accordance with the law, the principal establishes the school board. This board has 6 members:

- 2 members are appointed by the founder of the school
- 2 members are elected by legal representatives of minor pupils and adult pupils
- 2 members are elected by the teaching staff of the school

This is a by-election for the current member of the School Board from among legal representatives, who according to the above-mentioned law (§167, paragraph 9f) and according to the Electoral Rules for the School Board ceased to exist on August 31. 2024 membership due to the successful completion of her daughter's studies, who thereby ceased to be a pupil of the school.

Elected to the school board can be persons qualified for legal tasks.

1. Election of council members by adult pupils and legal representatives of minor pupils


Adult pupils of the school (they are over 18 years old on the day of the election) and legal representatives of minor pupils are entitled to vote.

The election of a member of the School Council will take place on Monday 23 September 2024 via electronic voting via the web application of the Edookit school information system - https://iso-login.edookit.net/

The time for electronic voting is set from 7:00 a.m. to 8:00 p.m. on the given day.

Method of logging into the system and selection

- 1. Log in to the Edookit system, use the access password that we gave to your children two weeks ago, parents have their own access code).
- 2. Section "Communication"
- 3. Click on the "Polls" link, here set the Views and Odds dashes (---) in the header, then you will see your poll



- 4. Enter the survey and make a choice
- 5. A maximum of one candidate can be selected
